



## AWARD OF DISTINCTION NOMINATIONS HONOUR THE INDUSTRY'S BEST - APRIL 14 TO 16, 2013

Alberta Hotel & Lodging Association members who exemplify the very best qualities of the people working in the accommodation industry may be nominated for the Award of Distinction. The following criteria are used to select award recipients:

- 1. The nominee must be a manager or owner/ operator of a property that has been an AHLA member in good standing for no less than 5 years. The nominee must be able to demonstrate support for the association and regular participation in AHLA programs, services and activities during this time.
- 2. The nominee must demonstrate professionalism and a commitment to excellence at their property, as well as the vitality of the tourism & hospitality industry locally and provincially.
- **3.** The nominee must have been a general manager or owner/operator for a minimum of 25 years.

The selection committee will review all eligible nominations for the Award of Distinction. To nominate an individual for this award, please complete the nomination form or submit a letter which includes:

- Name & contact information of nominator.
  The nominator must be another AHLA member in good standing.
- Name & property at which the nominee is currently employed.
- The nominee's employment history with dates.
- A detailed description of the nominee's achievements as a general manager or owner/operator in the accommodation industry.
- The nominee's involvement in their community and in Alberta's tourism & hospitality industry.
- Any other information that will assist the selection committee in making their decision, such as press releases or staff and guest feedback.
